AirBadminton Association of Hong Kong, China Limited **Affiliated Membership Application**

All local clubs or sports organizations that include AirBadminton as one of their activities may apply to become an affiliated member of the AirBadminton Association of Hong Kong, China Limited (hereafter referred to as "ABAHKC"). Each club or organization must submit a written application to the Honorary Secretary of ABAHKC, along with a membership fee of HKD 200 and an annual fee of HKD 100. The application shall be reviewed by the ABAHKC Committee, and if rejected, the relevant fees shall be refunded in full to the applicant.

Applicants must complete the Affiliated Membership Application Form and submit it together with the following information:

- Copy of Certificate of Registration of a Society / Business Registration / Registered **Educational Institute**
- (2) List of club office-bearers and members (including detailed titles and membership classification)
- Articles of Association (3)
- Club profile, past activities and development data (background, history, regular (4) activities, etc.)
- (5) Training venue and schedule
- List of registered coaches (6)
- Detailed financial / audit reports for the past 2 years (7)

Basic requirements for admission as an affiliated member:

- Registered under the "Societies Ordinance" or the "Companies Ordinance", or registered as an educational institution
- $\overline{\mathbf{Q}}$ Has a valid committee member organizational structure
- Has Articles of Association and a long-term development plan, including a regular training schedule
- $\overline{\mathbf{A}}$ Has not less than 20 active members, and a member supervision code of conduct
- Has experienced registered Badminton Association of Hong Kong, China (hereafter referred to as "BAHKC") coaches
- \square Financially stable with detailed financial / audit reports
- $\overline{\mathbf{Q}}$ Active participation in BAHKC and ABAHKC events
- Accepts the supervision of BAHKC and ABAHKC
- $\overline{\mathbf{Q}}$ ABAHKC possesses the final decision right to approve the membership application
- $\overline{\mathbf{Q}}$ Once becoming an affiliated member, one must comply with the rules and regulations of BAHKC and ABAHKC. ABAHKC shall not tolerate any illegal or unethical behavior. Upon approval by the board of directors, BAHKC has the right to terminate its membership with immediate effect and shall be posted on BAHKC website, and relevant partnerships shall also be notified.
- $\mathbf{\Lambda}$ Affiliated members are responsible for updating their club data (if there are any changes).

Membership Application Procedure

- Upon receipt of all necessary documents, ABAHKC shall submit them to the next Board of Directors' meeting for handling
- If the information provided by the applicants is incomplete or incorrect, ABAHKC shall request the applicants to provide an explanation or supplementary information. All information must be complete before approval
